**PRODUCT SUITABILITY**

**WHO IS THE PRODUCT SUITABLE FOR?**

- The Sub-Fund is only suitable for investors who:

  - are comfortable with the exposure to and the investment policy and approach of a Sharia compliant fund.

**KEY PRODUCT FEATURES**

**WHAT ARE YOU INVESTING IN?**

- You are investing in a sub-fund of the Singapore-constituted Maybank Focus Funds that aims to enhance the value of its assets in the medium or long term through investing all or substantially all its assets into the Master (USD Dist) class of AZ Islamic - MAMG Global Sukuk Fund (the “**Underlying Fund**”), a sub-fund of the Luxembourg-domiciled AZ Multi Asset.
- Class A (Dist) – SGD, Class A (Dist) – USD, Class I – SGD and Class I – USD have been established and you should check with the Manager’s authorised distributors as to which Classes are available for subscription.
- The Manager may, from time to time, decide to make distributions at such rate and frequency as it may decide in its absolute discretion.

**Investment Strategy**

- The Sub-Fund will invest all or substantially all of its assets into the Underlying Fund.
- With a view to enhancing the value of its assets in the medium or long term, the Underlying Fund shall normally invest in “Sukuk” Islamic securities instruments (floating-rate, fixed-rate, index-linked, subordinated and convertible securities), among others government and / or supranational securities, emerging credit instruments, corporate securities and / or convertible securities compliant with

Prices may be obtained from <a href="http://www.maybank-am.com.sg">www.maybank-am.com.sg</a>.</p> <p><b>HOW CAN YOU EXIT FROM THIS INVESTMENT AND WHAT ARE THE RISKS AND COSTS IN DOING SO?</b></p> <ul style="list-style-type: none"> <li>You can exit the Sub-Fund on any Dealing Day by submitting a completed realisation request to the Manager or the relevant authorised distributor through whom you originally purchased Units. If applicable to you and you wish to exit the Sub-Fund within the cancellation period of 7 calendar days from the time of your subscription, you may do so by submitting a cancellation request and you will not incur the subscription fee and fees stated above. However, you will have to take the risk of any price changes in the NAV of the relevant Class of the Sub-Fund since your subscription and pay any administration fees imposed by the Manager or its relevant authorised distributor.</li> <li>The Manager may, with the approval of the Trustee, limit the total number of Units which holders of the Sub-Fund or Class may realise and which the Manager is entitled to have cancelled on any Dealing Day to 10% (or such higher percentage which the Manager may determine in any particular case) of the total number of Units relating to the Sub-Fund or Class then in issue (disregarding any Units which have been agreed to be issued).</li> <li>You will normally receive the realisation proceeds within 7 Business Days from the Dealing Day on which your realisation request is received and accepted.</li> <li>The realisation price of your Units is determined as follows: <ul style="list-style-type: none"> <li>If you submit the realisation request by 5 p.m. Singapore time on a Dealing Day, you will be paid a price based on the NAV of the relevant Class of the Sub-Fund as at the Valuation Point of that Dealing Day.</li> <li>If you submit the realisation request after 5 p.m. Singapore time on a Dealing Day or on a day not being a Dealing Day, you will be paid a price based on the NAV of the relevant Class of the Sub-Fund as at the Valuation Point of the next Dealing Day.</li> </ul> </li> <li>The net realisation proceeds that you will receive will be the realisation price of the relevant Class of the Sub-Fund multiplied by the number of Units realised, less any charges. <b>APPENDIX: GLOSSARY OF TERMS</b>	
<b>Business Day</b>	A day (other than Saturday, Sunday or a gazetted public holiday) on which commercial banks are open for business in Singapore, or any other day as the Manager and the Trustee may agree in writing.
<b>Class</b>	Any class of Units in the Sub-Fund which may be designated as a class distinct from another class in the Sub-Fund as may be determined by the Manager from time to time.
<b>Dealing Day</b>	In connection with the issuance, cancellation, valuation and realisation of Units of the Sub-Fund, a Business Day or such other day or days at such intervals as the Manager may from time to time determine with the prior consultation of the Trustee, provided that reasonable notice of any such determination will be given by the Manager to all affected holders at such time and in such manner as the Trustee may approve. If on any day which would otherwise be a Dealing Day, the recognised market on which investments of the Sub-Fund having in aggregate values amounting to at least 50% of the value of the deposited property of the Sub-Fund (as at the relevant Valuation Point) are quoted, listed, or dealt in is not open for normal trading, the Manager may determine that such day shall not be a Dealing Day.
<b>FDIs</b>	Financial derivative instruments.
<b>Launch Date</b>	For the purposes of this Product Highlights Sheet only, means the inception date of the Sub-Fund, which is the date on which the first Class of the Sub-Fund was incepted.
<b>NAV</b>	Net asset value.
<b>Underlying Fund</b>	AZ Islamic – MAMG Global Sukuk Fund, a sub-fund of the Luxembourg-registered AZ Multi Asset.
<b>Units</b>	Units in the Sub-Fund.
<b>Valuation Point</b>	The close of business of the last relevant market on a Dealing Day or such other time on that day or such other day as the Manager may determine with the prior approval of the Trustee, who shall determine if a notice to notify the affected holders of such change is required.
