### MAYBANK MONEY MARKET FUND

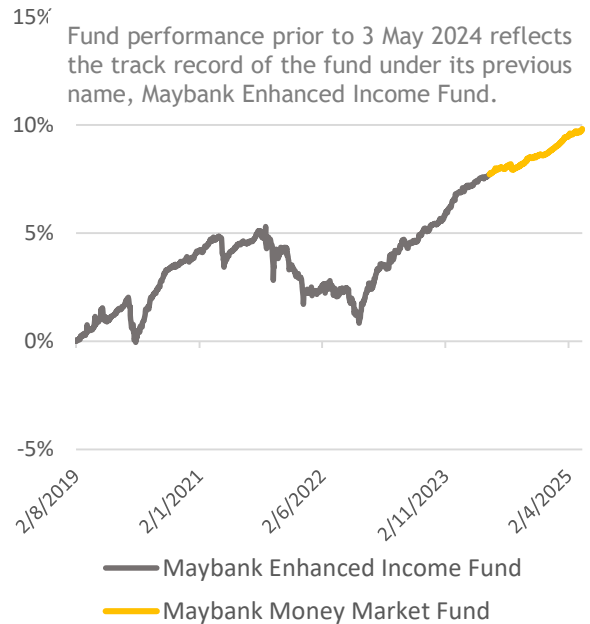
#### INVESTMENT OBJECTIVE

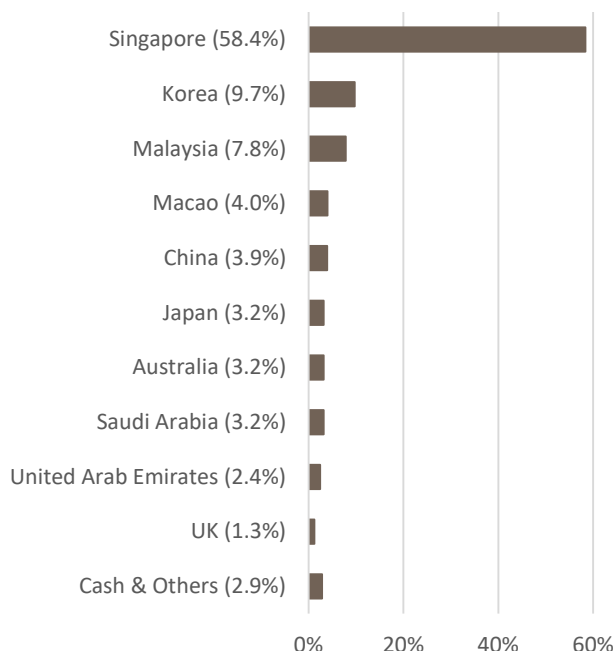
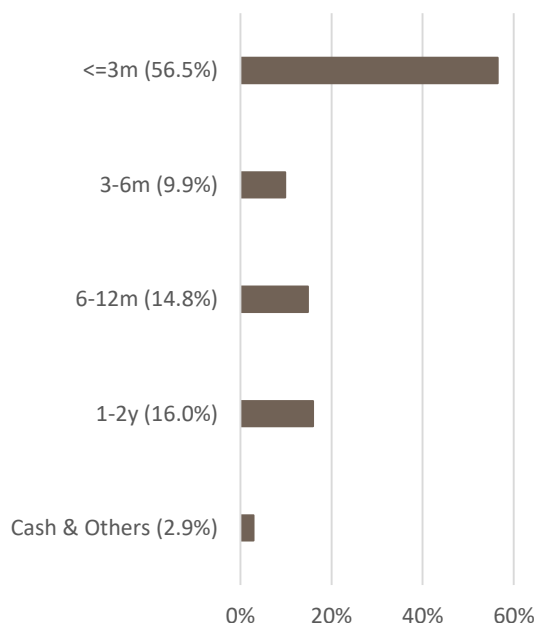
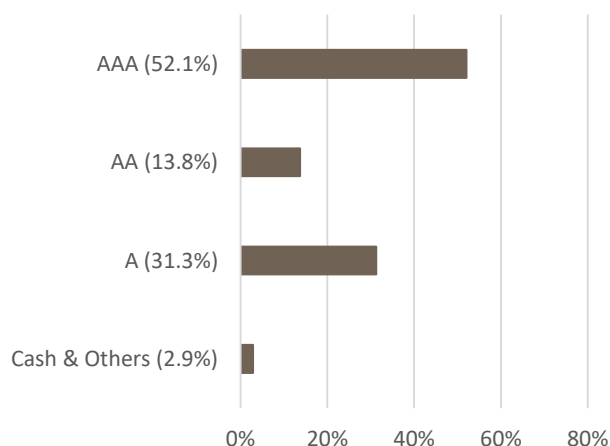
