





FUND MANAGER'S COMMENTARY

Global fixed income markets posted strong gains in June, demonstrating resilience amid heightened geopolitical tensions and shifting U.S. macroeconomic expectations. Risk sentiment initially deteriorated following a surprise Israeli strike on Iran's nuclear facilities and retaliatory attacks, including on a U.S. airbase in Qatar, which triggered a sharp spike in oil prices. However, markets quickly stabilized after a U.S.-brokered ceasefire between Israel and Iran de-escalated the situation, leading to a pullback in oil prices. Beyond geopolitical relief, the rally was underpinned by softening U.S. inflation data, weaker labor market indicators, and dovish signals from the Federal Reserve, which reinforced expectations of rate cuts later this year. Improved technicals, including subdued supply and strong demand for U.S. credit, further supported the rally. Notably, MENA credit markets remained stable throughout, with both investment-grade and high-yield segments delivering returns broadly in line with global benchmarks — reflecting investor confidence in the region's solid credit fundamentals despite the volatile backdrop
